The Marquette County Election Commission, at an open meeting, was informed that the Republic Township Board at their Organizational Meeting, did not perform the Oath of Office for their incumbent Township Officers. The incumbent Township Officers were (Treasurer, Clerk, and Trustee). The Oath of Office was completed for the newly elected Supervisor and Trustee, which left no quorum for the Township Board.

Pursuant to MCL 168.368, failure of an elected official to qualify and assume office creates a vacancy in that office. Further, MCL 168.368 provides that an immediate vacancy occurs if an official neglects to take the Oath of Office. Such vacancies are filled by the Township Board pursuant to MCL 168.370(1) and MCL 168.370a. If these offices in Republic Township are considered vacant, the board that only has two members and, therefore, not a quorum for purposes of conducting business and reappointing these members (3 members are required for a quorum in general law townships).

Further, MCL 168.370(2) provides that, if a township board falls below the number required for a quorum, the board of county election commissioners shall make a temporary appointment(s) to provide the board with a quorum for purposes of conducting business.

At an open meeting held on January 21, 2021 at 9:00 a.m., Anna Griepentiog was put forth as a temporary appointee (under MCL 168.370). It appears to the Election Commission that Anna Griepentiog is qualified to assume the temporary position. A vote was taken on the appointment of Ms. Griepentiog and the vote passed.

<u>Board action:</u> The Marquette County Election Commission appoints: Anna Griepentiog as Trustee for Republic Township to perform the duty as stated in MCL 168.370(2) as stated below.

MICHIGAN ELECTION LAW (EXCERPT) Act 116 of 1954

168.370 Elective or appointive township office; appointment to fill vacancy; temporary appointment; effect of resignation; special election; vacancy in office of township constable.

Sec. 370.

(2) If 1 or more vacancies occur in an elective township office that cause the number of members serving on the township board to be less than the minimum number of board members that is required to constitute a quorum for the transaction of business by the board, the board of county election commissioners shall make temporary appointment of the number of members required to constitute a quorum for the transaction of business by the township board.
