Appointed Twp Personnel Expense Breakdown – Motion by Trustee Stankus that if these personnel wish to be paid for their phone time, computer time, or any verbal discussion time to attach a list to their vouchers of these events of time spent, person spoken to or emailed and the subject matter, seconded by Supervisor Ulrich, Supervisor Ulrich asked if this would impinge on confidentiality, Clerk Brancheau stated that she thought it would and if one person has to, then everyone has to. Trustee Stankus felt that if we are going to charge extra on items such as zoning permits, how would we know what to charge if it isn't tracked in some way. Clerk Brancheau stated that she felt this was only an issue because of Gary Johnson's vouchers, Trustee Stankus disagreed. Trustee Stankus said he didn't think confidentiality was an issue. Mr. Honeyeager stated that the marijuana discussions have to be kept confidential because it involves the health of patrons and is protected by HIPAA, he went on to state that Mr. Johnson had been asked

to sign a Non-Disclosure agreement. Supervisor Ulrich asked Mr. Johnson if he had any other people he had been speaking to that needed confidentiality. Mr. Johnson stated that he currently had a bank, a realtor and two private individuals who fit that need that he had ongoing discussions with. Mr. Johnson then told Trustee Stankus that he needed to ask himself why he felt the need to attack him constantly. He went on to state that Trustee Stankus did not ask anyone else to do this, he has never questioned anyone else about their time. Mr. Johnson went on to state that Trustee Stankus has a personal vendetta against him, that he only ran for the board with another person because the group of people he associated with wanted to get rid of Mr. Johnson and several others on the Board. But since he had been the only one who made it on the Board, and since then you have not stopped. Mr. Johnson said that he has tried to be professional, he has tried to be gracious, to no avail. Trustee Stankus said that since Terry Knapp left the office of Zoning Administrator that the cost of that office has skyrocketed and most of it is phone calls, that Mr. Johnson spends a lot of time on the phone. He also stated that if Mr. Johnson wanted to threaten legal action he can go ahead and do it. Treasurer Koski stated, "call the question, there is a motion on the floor." Supervisor Ulrich stated that the motion had been seconded but only for the sake
